LEESBURG ROAD***

**PROHIBITIONS:**

Pursuant to 36 CFR 261.50 (a) and (b), the following act is prohibited on National Forest System Roads (NFSR) #021 Williams Creek Road #055 Panther Creek Road, , #076 Napias Creek Road, #098 Phelan Creek Road, #101 Deep Creek Road, #020 Ridge Road and #242 Leesburg Road on the Salmon-Cobalt and North Fork Ranger Districts of the Salmon-Challis National Forest ("Closed Road"), which is shown on the attached map and incorporated into this Order:

1. Being on the Closed Road from July 26, 2021 to September 1, 2021 - 36 CFR 261.54(e); 36 CFR 261.55(a)

**EXEMPTIONS:**

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order; and
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

**DESCRIPTION OF CLOSED ROADS:**

The portion of NFSR #055 Panther Creek Road between where it intersects NFSR #030 Salmon River Road to where it intersects NFSR #101 Porphyry Creek Road.

The portion of NFSR #020 Ridge Road from where it intersects NFSR #021 Williams Creek Road to where it intersects NFSR #023 Stormy Peak Road.

The portion of NFSR #021 Williams Creek Road between where it intersects NFSR #020 Ridge Road to where it intersects #076 Napias Creek Road and #101 Deep Creek Road.

The portion of NFSR #242 Leesburg Road between where it intersects #076 Napias Creek Road and #098 Phelan Creek Road.

All of NFSR #076 Napias Creek Road.

All of NFSR #098 Phelan Creek Road.

All of NFSR #101 Deep Creek Road.

**PURPOSE:**

The referenced roads are closed to all uses to protect public health and safety from the effects of the Mud Lick Fire.

**IMPLEMENTATION:**

1. This Order will be in effect when signed and shall remain in effect through September 1, 2021.
2. A map identifying the Closed Road is attached and made part of this Order.

3. Any violation of the prohibition in this Order is punishable by a fine of not more than \$5,000 for individuals, and \$10,000 for organizations and/or imprisonment for not more than six months. [16 USC § 551, 18 USC §§ 3559, 3571, 3581.
4. This Order supersedes any previous orders prohibiting the same acts covered by this Order.
