UNITED STATES DEPARTMENT OF AGRICULTURE FOREST SERVICE SALMON CHALLIS NATIONAL FOREST SALMON COBALT RANGER DISTRICT TRAILS 010, 023, 026, 028, and 029 CLOSURE

PROHIBITIONS:

Pursuant to 36 CFR 261.50(b), the following act is prohibited on National Forest System Trails (NFSTs) #010 Lick Creek, #023 and #028 Gant Ridge, #026 Indian Creek, and #029 Big Deer on the Salmon-Cobalt Ranger District of the Salmon Challis National Forest ("Closed Trails"), which are shown on the attached map incorporated into this Order:

1. Being on the Closed Trails from July 10 to August 31, 2021 - 36 CFR 261.55(a)

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

- 1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order; and
- 2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

DESCRIPTION OF CLOSED TRAILS:

All of NFSTs # 010 Lick Creek, #023 and #028 Gant Ridge, #026 Indian Creek, and #029 Big Deer.

PURPOSE:

NFSTs # 010 Lick Creek, #023 and #028 Gant Ridge, #026 Indian Creek, and #029 Big Deer are closed to all uses, including hiking, biking, motorized use, and horse travel, to protect public health and safety from the Mud Lick Fire and its effects.

IMPLEMENTATION:

- 1. This Order will be in effect when signed and shall remain in effect through August 31, 1021.
- 2. A map identifying the Closed Trails is attached and made part of this Order.
- 3. Any violation of the prohibition in this Order is punishable by a fine of not more than \$5,000 for individuals, and \$10,000 for organizations and/or imprisonment for not more than six months. [16 USC § 551, 18 USC §§ 3559, 3571, 3581.
