*Haynes Fire Road Closure***

PROHIBITIONS:

Pursuant to 16 U.S.C. § 551 and 36 CFR 261.50 (a) and (b), the following acts are prohibited on the National Forest System (NFS) lands, roads, and trails in the Salmon-Cobalt Ranger District of the Salmon-Challis National Forest described below and shown on the attached map incorporated into this Order as Exhibit A (the “Closed Roads and Trails”):

1. Being on the Closed Roads and Trails. 36 CFR 261.54(e), 261.55(a)

EXEMPTIONS:

Pursuant to 36 CFR 261.50(e), the following persons are exempt from this Order:

1. Persons with a special use authorization or other Forest Service authorization specifically exempting them from the effect of this Order; and
2. Any Federal, State, or local officer, or member of an organized rescue or fire fighting force in the performance of an official duty.

DESCRIPTION OF CLOSED AREA, ROADS, AND TRAILS:

Closed Area:

All of National Forest System Road (NFSR) #60152 Baldy Basin Road

All of NFSR #60016 Haynes Basin Road

All of NFSR #60427 K Mountain Road

All of NFSR #60014 Twelve-mile Creek Road.

Closed Roads and Trails: All NFS roads (NFSR) described above and shown on Exhibit A.

PURPOSE:

The purpose of this Order is to protect public health and safety from the effects of the Haynes Creek Fire.

IMPLEMENTATION:

1. This Order will be in effect when signed and shall remain in effect through August 31, 2021.
2. A map identifying the Closed Area is attached and made part of this Order.
3. Any violation of the prohibition in this Order is punishable by a fine of not more than \$5,000 for individuals, and \$10,000 for organizations and/or imprisonment for not more than six months. [16 U.S.C. § 551, 18 U.S.C. §§ 3559, 3571, 3581].

4. This Order supersedes any previous orders prohibiting the same acts covered by this Order.
