SYNOPSIS:

On 10/15/21 at approximately 23:28 hours, Pocatello Police Dispatch received a call from MICHAEL SMITH, date of birth [REDACTED] that he heard several gunshots in the area of [REDACTED], Pocatello, Bannock County, Idaho. MICHAEL SMITH also told dispatch that a male named JESSE had shot the gun 6 times and left on foot westbound on Phoenix. MICHAEL SMITH went to [REDACTED] and located a female deceased in the residence.

Pocatello Police Dispatch sent officers to the residence to conduct further investigation into this matter. Officers went to the residence and conducted an

exigent circumstances entry into the residence. Sergeant SHUTES, Corporal Seamons, Officer Summers and Officer Saldana arrived on scene and located one deceased male and one deceased female inside Trailer [REDACTED]. Both deceased victims had what appeared to be blood pooling around their heads. No other subjects, alive or dead, were located inside the trailer. The subjects found deceased at the trailer were JENNIFER LEIGH, date of birth [REDACTED] and TIMOTHY HUNT, date of birth [REDACTED]. It should be noted that JENNIFER LEIGH is married to JESSE LEIGH and they are recently estranged. JENNIFER LEIGH had moved out of [REDACTED] and had been staying with TIMOTHY HUNT at 291 W. Burnside, Extended Stay Pocatello, in Chubbuck, Idaho.

While officers were on scene they were advised that JESSE PATRICK LEIGH, (DOB: 10-24-81) was seen by witnesses running from Trailer [REDACTED] shortly after the shots had been fired. Officers from the Bannock County Sheriff's Office, Chubbuck Police Department, and Pocatello Police Department located JESSE LEIGH at his mother, JUDY LEIGH's, residence at [REDACTED] in Chubbuck, Bannock County, Idaho. JESSE LEIGH was in possession of a black 9mm semiautomatic GIRSAN handgun bearing serial number [REDACTED]. The firearm was partially loaded with one round in the chamber and 7 rounds in the magazine, which can hold a total of 18 rounds. The firearm was located with the hammer cocked back and the safety switch on fire. This is indicative of a firearm that had been recently fired, or one that was being prepared to fire. At the time he was located, JESSE LEIGH had what appeared to be blood on his clothing. The officers detained JESSE LEIGH and transported him to the Pocatello Police Department. JESSE LEIGH made several excited utterances to Detective EBORN including asking "Are they dead?" and that he had made a mistake. I attempted to interview JESSE LEIGH at the Pocatello Police Department. I advised him of his Miranda Rights with the Pocatello Police Department Adult Rights Form. JESSE LEIGH invoked his right to have an attorney and no other questioning was conducted.

SGT. VANDERSCHAAF completed a Verified Petition for Detention for Purpose of Obtaining Evidence for JESSE LEIGH and submitted it to the honorable Judge Jarman. Judge Jarman signed an Order of Detention authorizing seizure of JESSE LEIGH's clothing and to collect samples from his person. I noticed that JESSE LEIGH had suspected blood on his outer clothing, particularly on his right jacket sleeve, and the right leg of his jeans. I seized the clothing to submit for further forensic analysis and comparison.

Detective WRIGHT and Detective MARSHALL interviewed JESSE LEIGH's mother JUDY LEIGH regarding this case. JUDY LEIGH said that she and her husband STEVEN HONAS were at their residence [REDACTED], Chubbuck, Bannock County, Idaho when they heard loud noises coming from the back of the residence. STEVEN HONAS went to investigate and found that JESSE LEIGH had forced entry into their residence. JUDY LEIGH said JESSE LEIGH and JENNIFER LEIGH are married but are currently separated. JENNIFER LEIGH is involved in a relationship with her new boyfriend TIMOTHY HUNT. JUDY LEIGH said she spoke with JESSE LEIGH and he made statements about TIMOTHY HUNT and JENNIFER LEIGH breaking into his house and that they had guns. JUDY LEIGH said that JESSE LEIGH told her something to the effect of "I shot them, mom. I shot them. I just couldn't take it anymore. They barged in the house. I love you mom, I'm sorry. I couldn't help it. They were making fun of me." JUDY LEIGH believed JESSE LEIGH fled from her residence on foot after they spoke.

Detective WRIGHT and Detective MARSHALL interviewed JUDY LEIGH's husband STEVEN

HONAS about this incident. STEVEN HONAS said he and JUDY LEIGH were sleeping in the residence and he heard a loud banging at the back door. STEVEN HONAS went to investigate and found that JESSE LEIGH had forced entry into their residence.

STEVEN HONAS said that JESSE LEIGH told him that JENNIFER LEIGH and her boyfriend were kicking and harassing him. JESSE LEIGH told STEVEN HONAS something to the effect of "I shot them and they're probably dead. I'll probably be the next one." STEVEN HONAS believed that JESSE LEIGH fled from his residence after they spoke.

Detective BARTSCHI conducted an interview with TERRY JAMES CAMERON, date of birth [REDACTED] about this incident. TERRY CAMERON had been hanging out with JENNIFER LEIGH, her son E [REDACTED] I [REDACTED], and TIMOTHY HUNT earlier in the evening on 10/15/21. TERRY CAMERON said they all went to [REDACTED] to drop E [REDACTED] I [REDACTED] off with his father JESSE LEIGH. They were all in a black 2011 Acura MDX bearing Idaho license [REDACTED] and when they got to the residence, JENNIFER LEIGH and E [REDACTED] I [REDACTED] went up to the door. E [REDACTED] I [REDACTED] came back to the vehicle and asked TIMOTHY HUNT for help getting in the residence because the door wouldn't open. TERRY CAMERON said that TIMOTHY HUNT went to help get the door open at [REDACTED] to gain access to the residence. TERRY CAMERON said a short time later he heard gunshots. TERRY CAMERON said after he heard the shots, E [REDACTED] I [REDACTED] ran out of the residence to the black Acura MDX and told TERRY CAMERON to "run." TERRY CAMERON ran from the residence and eventually flagged down Officer ALVARADO in the area.

Detective BARTSCHI conducted a detailed interview with MICHAEL SMITH, the first reporting party that called Pocatello Police Dispatch to report this incident. MICHAEL SMITH said that he heard loud noises outside his residence at [REDACTED] [REDACTED] which is directly next door to JESSE LEIGH's residence at [REDACTED]. MICHAEL SMITH heard gunshots and then called 911 to report this. MICHAEL SMITH said he went outside and saw JESSE LEIGH talking to E [REDACTED] I [REDACTED]. MICHAEL SMITH heard JESSE LEIGH say to E [REDACTED] I [REDACTED] something to the effect of "I've done something bad" and he repeated it several times. MICHAEL SMITH approached JESSE LEIGH and asked "what's going on?" JESSE LEIGH replied "I need you to take E [REDACTED]" MICHAEL SMITH said JESSE LEIGH ran on foot westbound on Phoenix away from the scene. MICHAEL SMITH and his wife JESSICA SMITH spoke with E [REDACTED] I [REDACTED] at their residence and E [REDACTED] I [REDACTED] made several statements to them about the incident. During those statements, E [REDACTED] I [REDACTED] said he came to [REDACTED] [REDACTED] with his mother JENNIFER LEIGH, TERRY CAMERON, and TIMOTHY HUNT. TERRY CAMERON stayed in the car while JENNIFER LEIGH, TIMOTHY HUNT, and E [REDACTED] I [REDACTED] had to force their way into the residence and found JESSE LEIGH asleep on the floor under a blanket. E [REDACTED] I [REDACTED] assumed that JESSE LEIGH had the pistol already. JENNIFER was on the couch, TIMOTHY was by the door and TIMOTHY told E [REDACTED] to "run." JESSICA SMITH and MICHAEL SMITH both wrote down notes about what E [REDACTED] I [REDACTED] told them. They had quotes indicating that E [REDACTED] also said "my dad was asleep on the floor, my mom kicked him, my dad said 'what are you doing here?' she said 'dropping off the kid, what does it look like?'" "He was really drunk, maybe that's why he shot." "My mom checked the camera and said it's not on."

Detective BARTSCHI was able to obtain surveillance footage from the residents at [REDACTED]. [REDACTED] JODY ANDERSON and ELLA ANDERSON. The footage shows the vehicle determined to be the black Acura MDX pull up in front of the residence and subjects exit and approach the residence. There is also footage of three subjects talking in front of the residence, and then one runs to the west from [REDACTED] past [REDACTED] on Phoenix. The male subject running was later determined to be

JESSE LEIGH. It should be noted that JESSE LEIGH was wearing the same jacket in that video as he was wearing when I served the Order of Detention to seize his clothing.

Detective BALLARD, Detective ELDRIDGE, Evidence Technician RIFELJ, and Evidence Technician CARRILLO completed scene processing at the residence after a search warrant had been signed by the honorable Judge JARMAN. There were several 9mm cartridge cases located inside the residence. The two deceased victims, JENNIFER LEIGH and TIMOTHY HUNT, appear to have obvious gunshot wounds on their persons. Specifically, JENNIFER LEIGH appeared to have a gunshot wound to the head and TIMOTHY HUNT appeared to have gunshot wounds to his left arm and on the left side of the middle of his back.

I arrested JESSE LEIGH on two counts of Voluntary manslaughter and had Officer HURLEY transport JESSE LEIGH to the Bannock County Jail. I incarcerated JESSE LEIGH on those charges and he will be held pending arraignment.

Investigation Narrative

On 10/15/21 at approximately 2334 hours, I responded to the area of [REDACTED] for the report of an agency assist. I was in the area of Siphon and [REDACTED] when I heard Pocatello dispatch advise of a male only known at the time as Jesse who had responded into a residence where several gunshots could be heard. The reporting party advised that upon going to check the residence after Jesse left he found a deceased person inside. The last known location of the suspect was westbound on Phoenix.

As I neared the area I overheard a Pocatello Police Officer arrive to the area and make contact with a male dressed in a dark jacket and jeans which was what the suspect was wearing near the entrance onto [REDACTED]. I prepared to stop with the officer although I was told that the suspect was possibly last seen headed south on [REDACTED] in a silver car. I clarified with the Pocatello unit that she was OK and that she wanted me to look for the car. After the confirmation I continued south on [REDACTED] until I arrived at Hwy 30 where I could see taillights near Simplot approximately one mile to the west.

I sped up to catch up to the vehicle and ultimately entered I86 westbound. As I did so I learned the vehicle was possibly a silver Dodge Caliber and a license plate was acquired through dispatch. I caught up to the vehicle that I believed was the one I had seen coming from the area on I86 near mile marker 54 where I conducted a traffic stop. The vehicle was a dark colored Dodge Journey and it did not have a license plate. It was apparent the vehicle was not involved and I

ultimately cleared the stop with no action taken with the driver or its occupants.

I responded back to the area where it was learned that the suspect had fled on foot and it was believed the silver Caliber was not involved. I overheard around this time that there were two deceased people in the trailer.

I searched the surrounding area and into [REDACTED] under the direction of Officer McArthur. As I began to do so information was received that the suspect had gone to his parents home on [REDACTED] in Chubbuck where he had admitted to the killings. We were advised that Jesse had said his good-byes and left the residence.

Upon arriving to the area to begin checking. I heard several units begin checking [REDACTED] and the neighborhood to the west along with Cotant Park. I responded with Deputy Green to the south near Alpine and that neighborhood to begin checking the Canal banks as the canals would allow someone to go un noticed between Pocatello and Chubbuck. Ultimately I parked my patrol vehicle where I recovered my Patrol Rifle and began checking the area on foot with Deputy Green. We were unsuccessful in our search.

Eventually there was a plan put in place to check the parents property to ensure that Jesse had not just hidden in an outbuilding. As Pocatello Officer Eborn and the Chubbuck Officers entered the residence I overheard on the air that the suspect had been located, was detained, and a firearm was secured.

Upon my arrival Eborn asked that I transport the suspect Jesse Leigh to the Pocatello Police department. As he was escorted to my patrol vehicle I conducted a patdown only to locate a key in his pocket. While doing the patdown I noticed blood on his pant leg. As I transported Jesse he merely advised something to the effect of, " they were kicking me, you can check the camera." Jesse was on an off emotional although nothing else of interest was noticed.

Once we arrived I escorted Jesse inside into a holding cell and he was released from my custody.

I ended the call with no further action taken.
