Idaho Permit Issuance Plan for Calendar Year 2023

The Idaho Department of Environmental Quality's (DEQ's) permit issuance plan for calendar year 2023 provides the regulated community, US Environmental Protection Agency (EPA), and other state, federal, tribal, and interested organizations with information regarding permits being developed by DEQ's Idaho Pollutant Discharge Elimination System (IPDES) Bureau. Permits are generally developed according to this list, although special circumstances may result in deviation from the schedule (e.g., new sources or dischargers, application withdrawals or Notices of Terminate, or total maximum daily load changes).

Individual facilities are rated based on the following criteria:

- Type of facility applying for a permit
- Length of time a facility has been waiting to be issued its first permit
- Length of time until an existing permit expires
- Length of time a permit has been administratively continued
- Receiving water beneficial use status
- Facility compliance history
 - Number of significant noncompliance issues during past permit cycle
 - Number of reporting noncompliance issues during past permit cycle
- Facility classification as a major or a minor discharger
- Number of drinking water system intakes within 500 feet downstream of a facility's discharge point

Permit Issuance for Individual IPDES Permits

Table 1 and Table 2 identify POTW (publicly and privately owned treatment works) and non-POTW¹ permit development statuses for *Pending* (new) and *Administratively Continued* permits:

- Development—actively being prepared
- Queue—in queue to be assigned and prepared
- On Hold—on hold due to specific circumstances (e.g., inactive discharge, etc.)

Permits are listed in order of highest priority scoring. Although these tables general guide the permit development prioritization, some permits may be developed out of order due to specific circumstances (e.g., discharging to shared waterbodies, draft permit development was already in progress, changes to waterbody impairments or facility operations, etc.).

¹ Some non-POTW permits process domestic wastewater and mirror POTW requirements using best professional judgement (BPJ).
