## COUNT I MURDER IN THE FIRST DEGREE Felony, Idaho Code § 18-4001; 4002; 4003; 4004 Penalty: 10 years-Life or Death and \$50,000 fine

That the Defendant, Jeremy Albert Best, on or about November 30, 2023, in the County of Teton, State of Idaho, did willfully, unlawfully, deliberately, with premeditation and malice aforethought and without legal justification, kill Mrs. Kali Randall Best, a human being, by shooting her in the back and/or right breast and/or right side and causing her death.

**COUNT II** 

MURDER IN THE FIRST DEGREE

Felony, Idaho Code § 18-4001; 4002; 4003; 4004

Penalty: 10 years-Life or Death and \$50,000 fine

That the Defendant, Jeremy Albert Best, on or about November 30, 2023, in

the County of Teton, State of Idaho, did willfully, unlawfully, deliberately, with

premeditation and malice aforethought and without legal justification, kill a human

fetus carried by Mrs. Kali Randall Best by shooting Mrs. Best and causing the

fetus's death.

**COUNT III** 

USE OF A FIREARM DURING THE COMMISSION OF A CRIME

Enhancement, Idaho Code § 19-2520

Penalty: Additional 15 years

That the Defendant, Jeremy Albert Best, on or about November 30, 2023, in

the County of Teton, State of Idaho, did use a firearm in the commission of the crimes

alleged in Counts I and II.
