INDICTMENT (Redacted)

GERALD L. HAMLIN is hereby accused by the Grand Jury of Bonneville County of the crime of PRINCIPAL TO FIRST DEGREE MURDER, ACCESSORY TO FIRST-DEGREE MURDER and DESTRUCTION, ALTERATION, OR CONCEALMENT OF EVIDENCE, felonies, Idaho Code §§ 18-204, 18-205, 18-4001, 18-4001-IAC and Idaho Code § 18-2603, committed as follows:

COUNT I: That the Defendant, GERALD L. HAMLIN, on or about the 19th day of May, 2022, in the County of Bonneville, State of Idaho, did aid and abet Randy Michael Larkin in the willful, unlawful, deliberate, with premeditation and with malice aforethought, killing of Morey P. Pelton, a human being.

COUNT II: That the Defendant, GERALD L. HAMLIN, on or about the 19th day of May, 2022, in the County of Bonneville, State of Idaho, having knowledge that

Randy Michael Larkin had committed the crime of Murder in the First Degree, Felony, I.C. § 18-4001, did willfully withhold or conceal that knowledge from a peace officer.

COUNT III: That the defendant, GERALD L. HAMLIN, on or about the 7th day of September, 2022, in the County of Bonneville, State of Idaho, did willfully destroy text message(s) between the Defendant and another suspect, knowing that the text message(s) were about to be produced, used or discovered as evidence in a felony inquiry or investigation authorized by law and with the intent to prevent it from being so produced, used or discovered.

All of which is contrary to the form, force and effect of the statute in such case made and provided against the peace and dignity of the State of Idaho.
